The Royal Government of Cambodia (RGC) through the Ministry of Economy and Finance receives financing from the World Bank toward the cost of the Road Connectivity Improvement Project (RCIP), and intends to apply part of the proceeds for Consulting Services. The Ministry of Public Works and Transport is the Executive Agency.

It is estimated that the services will require about 36 person-months of National Gender Specialist Services, on a full-time basis. - IV. Be fluent in spoken and written English
