NCB № MPWT-RNIP2-EQ-2: Supply and Delivery of Nine [9] Pick-up Trucks

1. The Kingdom of Cambodia receives a loan from the Asian Development Bank (ADB) toward the cost of Road Network Improvement Project, Phase 2 and it intends to apply part of the loan for payments under the Contract № MPWT-RNIP2-EQ-2 for supply and delivery of Nine [9] pick-up trucks.
2. The Ministry of Public Works and Transport now invites sealed bids from eligible and qualified bidders for supply and delivery of Nine [9] pick-up trucks.
3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of Asian Development Bank's Procurement of Goods and Works Guidelines.
4. This invitation is open to all eligible bidders from eligible source countries as described in the Bidding Document.

6. Qualification requirements as specified in ITB Clause 14.2, the Bidder shall furnish documentary evidence that it meets the following experience and financial requirements:
 - A manufacturer's authorization form is required;
 - The Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years of not less than 50% of the bid price in each contract;
 - The Bidder has completed contracts in the total cumulative amount equal to at least US\$700,000 in the preceding two years;
 - Access to a line of credit or cash in bank account of an amount at least 50% of the bid price (the date of cash in bank account should not be later than the date of bid submission or date of bid opening), net of other contractual commitments; or
 - Credit terms with vendors specifically for the goods to be supplied under the contract, of an amount at least 50% of the bid price and valid for at least 6 months after the deadline date for submission of bids specified in ITB clause 21.

10. All bids shall be accompanied by a Bid Securing Declaration as described in the Instructions to Bidders.

The Government and/or the ADB will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by them, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
