1. The Royal Government of Cambodia has received financing from the International Development Association (IDA) toward the cost of the Road Connectivity Improvement Project, and intends to apply part of the proceeds toward payments under the contracts named above.
2. The Ministry of Rural Development (“the Employer”) now invites sealed Bids from eligible Bidders for the improvement and maintenance of the following contract packages (the Works and Services”) of the Road Connectivity Improvement Project (“RCIP”), Ministry of Rural Development (“MRD”):

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as provided in the World Bank’s “*Procurement Regulations for IPF Borrowers (4th Edition)*” published in November 2020 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information and/or inspect the bidding documents by contacting the address given below during the office hours from 08:00 -12:00 hours in the morning and 14:00-17:00 hours in the afternoon.
5. The bidding documents in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of USD 300 (Three Hundred US Dollars) for this package.

The method of payment will be direct deposit of cash to the account below. The Bidding Document can be picked up at the office of PMU/MRD upon submission of a written application and proof of payment.
