The Royal Government of Cambodia (RGC) has received a loan from the Asian Development Bank (ADB) toward the cost of Skills for Competitiveness (S4C) Project, and it intends to apply part of the proceeds of this loan to payments under the Contract Reference No. AFD-DGTVET-ITC01-G-Lot 2 for the Supply, Delivery, and Installation of Basic Training Equipment for Electricity and Electronics to 5 selected Technical Training Institutes (TTIs) located in Phnom Penh, Battambang, Siem Reap, and Svay Rieng Provinces. Bidding is open to bidders from eligible source countries of ADB.
  2. The Project Management Unit of the Ministry of Labour and Vocational Training (MLVT) ("the Purchaser") invites sealed bids from eligible bidders for Open Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all bidders from eligible countries as described in the Bidding Document.
 

**The Bidder shall complete for all required items on a lot basis and the evaluation shall also be lot wise as stipulated in "The Bidder evaluation and qualification criteria" including in Section II of the bidding document.**
  3. Procurement will be conducted through National Open Competitive Bidding Procedures specified in Procurement Plan and the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of Asian Development Bank.
  4. This invitation is open to all eligible bidders from eligible source countries as described in the Bidding Document.
  5.   6. **Qualification requirements include:**
    - ❖ The documentary evidence of the Bidder's qualifications to perform the contract if its bid is accepted shall establish to the Purchaser's satisfaction:
      - a) Copies of original documents defining the constitution or legal status, place of registration, and principal place of business evidencing legal status in an eligible source country as defined in GCC Sub-Clause 6.1.
      - b) If indicated in the BDS that, in the case of a Bidder offering to supply goods under the contract which the Bidder did not manufacture or otherwise produce, the Bidder has been duly authorized by the goods' Manufacturer or producer to supply the goods in Cambodia.
  7.     - c) The Bidder shall furnish documentary evidence that it meets the following experience and financial requirements.
    - d) that the Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years (2021, 2020, and 2019) of not less than **40%** of the bid price in each contract as specified in the **BDS**;
      - i. that the bidder has completed contracts in the total cumulative amount equal to at least two times the value of the bid price in the preceding three years (2021, 2020, and 2019) as specified in the BDS.
      - ii. that the Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years (2021, 2020, and 2019) in the manufacturing of similar goods;
      - iii. that the Bidder has availability of liquid assets through either:
        - a) access to a line of credit or cash in bank account of an amount at least 50% of the estimated value of bid price in each contract, net of other contractual commitments; or
        - b) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
      - iv. that, in the case of a Bidder not doing business within Cambodia, the Bidder is or will be (if awarded the contract) represented by an Agent in Cambodia equipped and able to carry out the Supplier's maintenance, repair, and spare parts stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications;
      - v. that the Bidder gives to the Purchaser the authority to seek references from the Bidder's bankers; and
      - vi. that the Bidder meets any additional qualification criteria listed in **BDS**.
